The European Chemicals Agency (ECHA) has identified a Candidate List of Substances of Very High Concern (SVHC) for Authorization. This list is available on the ECHA's website <http://echa.europa.eu/>. This list will be regularly updated when more substances are identified as SVHC. ECHA urges companies to check their potential obligations resulting from the Candidate List.

Griswold LLC KUSHON® Natural Rubber products do not contain any SVHC above 0.1% by weight, per the ECHA Candidate List dated June 25, 2020.

ECHA also places restrictions on the content of eight Polycyclic-aromatic hydrocarbons (PAH) listed in Annex XVII, Entry 50. Paragraph 5 limits PAH content to 0.0001% by weight in rubber articles. Based on analytical testing of PAH levels in both the process oils and finished product, Griswold LLC KUSHON® Natural Rubber meets the requirements of Annex XVII, Entry 50, paragraph 5.

Reference the latest amendment (Commission Regulation (EU) No 1272/2013) to Annex XVII, Entry 50. This amendment places restrictions on the manufacture, placing on the market and use of certain dangerous substances, mixtures, and articles. It places limits on PAH content for rubber articles supplied to the general public that come into direct as well as prolonged or short term repetitive contact with the human skin or the oral cavity.
